## PJM Interconnection, L.L.C.; Notice of Technical Conference

By order dated December 28, 2015,1 the Commission directed its staff to convene a technical conference in this proceeding, based on its finding that the issues raised by PJM Interconnection, L.L.C. As further specified by the Commission, issues to be addressed at the technical conference will include, but are not limited to: (i) PJM's ARR modeling and allocation processes; (ii) treatment of portfolio positions in allocating underfunding or surplus among FTR holders and the potential for market manipulation; and (iii) balancing congestion in ARR/FTR product design.
